Background

Summary of organisation and management structure:

- Rantan Holdings Pty Ltd trading as Creative Edge Training was established as a registered training
 organisation on 7 May 2016 .Tanya Howell is the Chief Executive Officer and Randy Howell looks
 after the administration and business development for the organisation. Beth Dwyer is the head
 trainer/assessor, provides staff training and instrumental in the development and conducting of the
 Boot Camps. There are four other trainer/assessors and Belinda Moore is an external validator for
 the RTO.
- The Boot Camps have become a signature for the RTO providing intensive training opportunities and are conducted primarily at the delivery location in Reedy Creek. The majority of training and assessment occurs in the workplace at the 'Training Academy' at the Reedy Creek location or visits from Creative Edge Training Educators to the student's workplace.

About this Report

This report details findings against the *Standards for Registered Training Organisations 2015* (Standards for RTOs 2015). If non-compliance has been identified, this report describes evidence of the non-compliance.

Where non-compliance has been identified, the Registered Training Organisation is accountable for identifying and correcting non-compliant practices and behaviours, particularly those that have had a negative impact on learners.

Correcting non-compliance may require:

- correcting a process or system that has led to the non-compliance, and implementing a revised process or system
- identifying the impact on learners and carrying out remedial action for current and past learners

Action required by RTO

RANTAN HOLDINGS PTY LTD did not meet all requirements for clauses 1.8 & 3.1.

The RTO is required to provide evidence that demonstrates:

Training and Assessment

Standards for RTOs Clause 1.8

- The RTO has corrected its assessment system for future students that ensures assessment complies with the assessment requirements of the relevant training package and is conducted in accordance with the Principles of Assessment and Rules of Evidence.
- The RTO has carried out remedial action to identify and address the impact the non-compliance may have caused to past students and current learners enrolled in the sampled training products that were assessed in a manner that did not meet the requirements of Clause 1.8.
- Remedial action needs to also cover past students and current learners assessed during the past 1 month.

Completion

Standards for RTOs Clause 3.1

- The RTO has rectified the non-compliance identified in respect of Clause 1.8 of the *Standards for RTOs* for the sampled training products to ensure that, in accordance with the requirements of Clause 3.1, AQF certification documentation is only issued to a learner who is assessed as fully meeting the requirements of the training product as specified in the relevant training package.
- The RTO has carried out remedial action to identify and address the non-compliance with Clause 1.8 may have caused to former learners who issued AQF certification and who were not assessed as fully were meeting the requirements as specified in the relevant training package.
- Remedial action needs to cover all learners who have been issued AQF certification documentation (including both qualifications and statements of attainment) for the sampled training products within the past 1 month).

The RTOs training and assessment practices are not compliant with the requirements of Clause 1.8 of the Standards for RTOs 2015, as the organisation did not demonstrate that it implements an assessment system that ensures assessment:

- a) complies with the assessment requirements of the relevant training package
- b) is conducted in accordance with the principles of Assessment contained in table (1.8.1) and the rules of evidence contained in table (1.8.2).

Evidence of non-compliant training and assessment practices includes:

SHB30416 Certificate III in Hairdressing

SHBHIND001 Maintain and organise tools, equipment and work areas

Completed student assessment records for PC demonstrate the RTO has not ensured sufficient evidence is gathered of the student's skills, therefore valid assessment has not been conducted. The assessor has not been assured that the learner has demonstrated the performance and knowledge evidence as described in the unit.

The practical assessment does not ensure two different work areas are identified in relation to checking electrical equipment. Consequently, it was determined that not all the performance evidence requirements have been addressed. For example, but not limited to:

 check electrical equipment located in each of the two chosen areas for loose wires; tag and report any faulty equipment

The practical assessment does not does not contain sufficient observable tasks to ensure that all required skills have been demonstrated under the unit's prescribed methods of assessment. For example, but not limited to:

 numeracy skills to complete basic calculations involving ratios to dilute cleaning and disinfection products The RTO stated some knowledge evidence requirements are embedded within the practical activities at the time of demonstration verbal questions were asked to confirm the learner's knowledge. However, the RTO stated the verbal answers are not recorded and the design of the assessment tool does not include provision for verbal answers to be recorded. Consequently, it was determined that not all the knowledge evidence requirements have been addressed. For example, but not limited to:

- common types of cleaning and disinfection products:
 - role, use and basic content of Safety Data sheets (SDS) or plain English workplace documents or diagrams that interpret SDS content
- safe manual handling techniques for moving and storing hairdressing or barbering equipment; those for bending, lifting and carrying heavy equipment
- types and correct use of personal protection equipment for maintaining hairdressing or barbering equipment and completing cleaning and disinfection activities

The RTO did not demonstrate assessment activities will ensure use of:

- personal protective equipment; skin barrier cream
- cleaning and disinfectant product; Safety Data Sheets (SDS) or plain English workplace documents or diagrams that interpret SDS content

Consequently, the RTO has not demonstrated it has met the assessment conditions of the above unit of competency.

SHBHCLS005 Provide on scalp full head and retouch bleach treatments

Completed student assessment records for IDC demonstrate the RTO has not ensured sufficient evidence is gathered of the student's skills, therefore valid assessment has not been conducted. The assessor has not been assured that the learner has demonstrated the performance and knowledge evidence as described in the unit.

The practical assessment does not ensure evidence is collected to demonstrate the skill of recording the following details of the bleach service in the history for each client services:

• contraindications and reaction to skin tests or products

The practical assessment does not does not contain sufficient observable tasks to ensure that all required skills have been demonstrated under the unit's prescribed methods of assessment. For example, but not limited to:

• oral communication skills to ask open and closed prove questions and actively listen to effectively interact with client and meet their needs.

SHB30516 Certificate III in Barbering

SHBHCUT0013 Provide men's general grooming services

Completed student assessment records for AS demonstrate the RTO has not ensured sufficient evidence is gathered of the student's skills, therefore valid assessment has not been conducted. The assessor has not been assured that the learner has demonstrated the performance and knowledge evidence as described in the unit.

The RTO stated some knowledge evidence requirements are embedded within the practical activities at the time of demonstration verbal questions were asked to confirm the learner's knowledge. However, the RTO stated the verbal answers are not recorded and the design of the assessment tool does not include provision for verbal answers to be recorded. Consequently, it was determined that not all the knowledge evidence requirements have been addressed. For example, but not limited to:

- contraindications to shaving:
 - o contagious disorders of the skin
 - abnormal skin conditions
 - presence of blemishes or moles
 - o sunburn
- basic aspects of local government, state and territory health regulations for use of razor types with emphasis on the prohibition of straight razor use

Questions in Assessment 1 does not ensure valid and sufficient assessment evidence will be captured and do not provide sufficient guidance to the learner as to the extent of the answers required.

Further to this, written answers in Assessment 1 provided by the student are inconsistent with the corresponding answers in the marking guide however they have been marked correct by the assessor.

• "The example(s) listed above provide guidance on the areas of non-compliance identified and are not a full list of each unit of competency requirements that have not been met. The organisation is responsible for providing evidence that demonstrates all unit of competency requirements are met".

Completion

Standards for RTOs Clause 3.1

Original Finding: Not compliant

Finding following additional evidence: Not yet determined

The RTO issues AQF certification documentation only to a learner whom it has assessed as meeting the requirements of the training product as specified in the relevant training package or VET accredited course.

The following evidence was reviewed in relation to completion:

- Completed assessments for students PC, IDC and AS
- Evidence as provided for Clause 1.8.

The RTO's practices in relation to learner completion are not compliant with the requirements of the *Standards for RTOs 2015,* as the non-compliance identified in relation to Clause 1.8 did not support that the RTO has and will only issue AQF certification documentation to a learner whom it has assessed as meeting the requirements of the training product as specified in the relevant training package.

Evidence of non-compliance includes:
